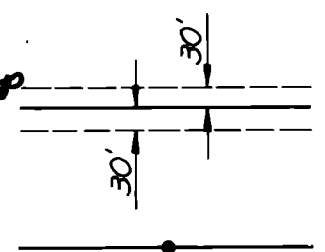

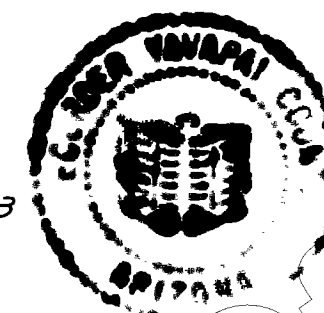
Denotes Set 3/8" Rebar w/ Aluminum Cap
