Aluminum Cap

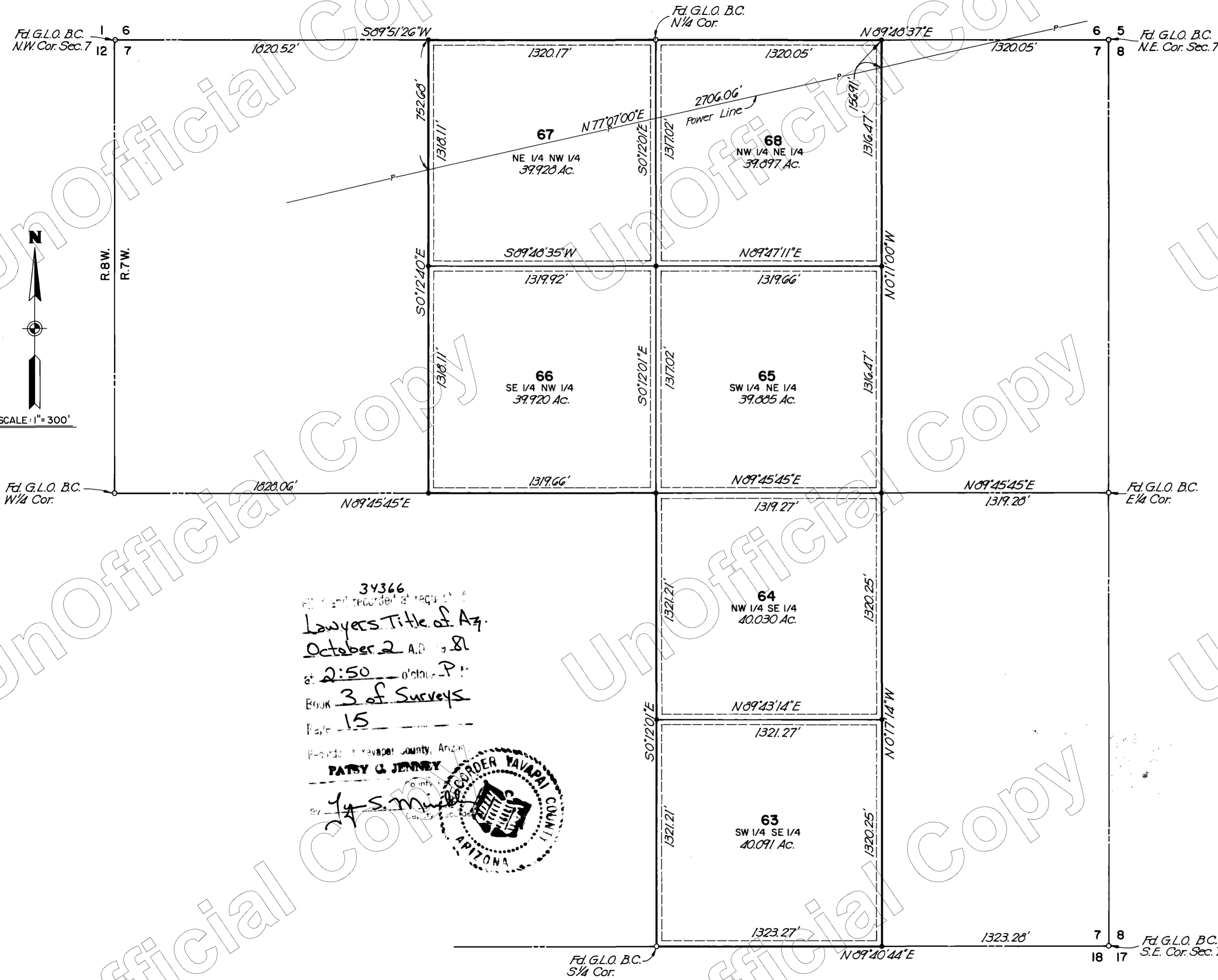
